The requirements for language interpreters are as follows:

AT LEAST 5 YEARS OF LANGUAGE INTERPRETING EXPERIENCE, preferably in the immigration and asylum sector

Possession of academic qualifications and/or diplomas from recognized institutions and/or bodies;

AVAILABILITY TO PROVIDE LANGUAGE INTERPRETING SERVICES FROM IMMEDIATE REMOTE "ON CALL" EITHER BY TELEPHONE OR VIDEOCONFERENCE

ABSENCE OF CONFLICT OF INTEREST, I.E:

- they have not themselves been recent applicants for international protection in Italy or in the country in/from which they will provide interpreting services in-person or online;
- are not politically affiliated with the governments or other political groups of the countries from which the applicants come from;
- have no relation to political parties, do not engage in political activity or participate in social or religious groups whose activities may constitute a conflict of interest with asylum seekers;
- if non-EU citizens, do not belong - even in an unofficial capacity - to the governments of their country of origin, including the embassies of the various countries present in the country of use.
